PUBLIC HEARING FOR 2nd 2021-2022 BUDGET AMENDMENT: Administrative Assistant Wright verified that public notice was advertised in The Bradenton Herald on September 4th, 2022 and read Resolution #2022-05. Finance Clerk Leissler summarized the items that were changed highlighting rising costs, supply and demand issues, and debt services after paying off the Station 1 loan.
