Budget Review & Preliminary Proposed Budget April 17, 2018

Chief Sousa stated that the preliminary proposed budget for 2018-2019 will be presented. Also, next month the board will have to adopt the resolution for the assessment rate. This presentation will be good as it will give some good alternatives as far as the assessment rates goes regarding the budget.

Administrative Assistant Kichar went over the mid-year budget. Currently all revenues are right in line for the year as well as expenses. We are right on target at 50% of budgeted amount for the year.

Battalion Chief Rigney then went over the preliminary proposed budget for 2018-2019 fiscal year. In doing the proposed budget staff worked it trying not to increase the assessment rate by using reserves. The personal income growth is 4.41%. In doing so however, we would probably have to go to 4% for next year. Chief Sousa stated that staff would prepare resolutions for next month's meeting for a zero increase and 2% increase for board to deliberate.

Commissioner Harris stated that it is important to know that we are retiring a note and thanked Commissioner Robinson. Discussion ended. Motioned passed unanimously.

CARRIED FROM CONSENT AGENDA: Commissioner Harris stated that the only thing he needs changed is the heading of the minutes from regular to special meeting. With that change Commissioner Harris motioned to approve; seconded by Commissioner Robinson; motioned passed unanimously.

OLD BUSINESS:

- A. Administration Building Update: Chief Sousa reported there is no update.
- B. Non-ad Valorem Assessment Exemptions: Chief Sousa reported there is no update.

NEW BUSINESS:

A. Sousa Employment Contract: Chief Sousa stated that on the dais he provided a copy of his employment agreement between himself and the District that expires on April 30th. In the agreement there is a provision for extension. Also provided was the employment agreement extension for a period of three additional years. Only adjustments would be increase in base salary and vacation time. Also provided was a spreadsheet of the salaries of other Fire Chief's in Manatee County. Commissioner Harris stated that he would just like to hear that the Chief would like to stay. Commissioner Robinson asked how he came up with the \$112,000? Chief Sousa stated that it was his request and compared to other area Chief's. Commissioner Robinson stated that if the Chief's is happy he is happy. Commissioner Bishop stated that for a CEO we are getting a great value and reiterated that if the Chief is happy he is happy. Commissioner Robinson motioned to approve the contract extension; seconded by Commissioner Harris; motion passed unanimously.

CHIEF'S REPORT: Chief Sousa reported that this past weekend there was a fire at the West Coast Surf Shop in Holmes Beach. What stood out was the staff was very proactive and made sure that everyone got out safely. Battalion Chief Rigney stated that there were no injuries to anyone. The fire was quickly knocked down. It appeared to be electrical in nature. Chief Sousa reported that he will be bringing a lease for the church property to next months meeting. We are still in the due diligence period for this building. We also will be having the audit presentation at next months meeting. Also, the labor contract agreement expires September 30th. Once we get started we will need to schedule an executive session. Commissioner Bishop asked who are the representatives for this negotiation? Chief Sousa stated that the bargaining team will be Chief Kiernan, Chief Jasinski, Chief Rigney and Julie. Commissioner asked if we could inquire about adding 6 months onto the contract so we can have completed prior to figuring out the budget year. Chief Sousa stated we could propose that. We will schedule a executive session in July and do facilities workshop in June.
