- 1. Call to Order The meeting was called to order at 9:00am by Dan Tackett.
- 2. Roll Call As reflected above.

The minutes from the January 31, 2018, quarterly meeting were approved upon motion by Dale Stephenson and second by Scott Ricci, motion carried 4-0.

- 5. New Business None
- 6. Old Business
 - a. Further discussion of the investment return assumption.
 - i. Dan Tackett reviewed a handout provided by the Fire Chief which addressed the assumption rate. Lee Dehner informed the board there had been a pattern around the State to begin lowering the investment return assumption. The Chief recommended reducing the current rate by 25 basis points using a glide path strategy over the next five years. Stewart Moon agreed the current rate was too high.

The board approved gradually lowering the investment return assumption by 25 basis points over five years beginning with the October 1, 2018 actuarial valuation report, upon motion by Scott Ricci and second by Stewart Moon, motion carried 4-0.

7. Reports

- a. Dana Investment Advisors, Greg Peters, Investment Manager
 - i. Quarterly report as of March 31, 2018
 - 1. Greg Peters reviewed the market environment stating it had been a bumpy quarter with the S&P down. Overall there had been good performance during the last twelve months. Stewart Moon asked what the expectation was going forward into the next quarter. Greg Peters commented it was hard to predict but the debate is that growth will either continue into 2021 or it will end at the end of this year or early 2019.
 - 2. Portfolio value as of March 29, 2018, was \$4,730,966.71, a gain of \$185,911.14 over the last quarter.

3. Equity gross returns for the quarter were -0.44%, outperforming the S&P 500 of -0.76%. Fiscal gross YTD returns were 7.52%,

outperforming the Index of 5.84%.

4. Fixed gross income returns for the quarter were -0.91%, outperforming the Barclays Intermediate Aggregate of -1.06%. Fiscal gross YTD returns were -0.97%, outperforming the benchmark of -1.13%.

b. AndCo Consulting, Kerry Richardville & Jack Evatt, Investment Consultants.

i. Quarterly report as of March 31, 2018.

 Kerry Richardville reviewed the market environment stating 2017 had record low volatility. Factors at play were inflation concerns due to wages rising quickly. Equities and the S&P were down. Fundamentals both here and abroad were still solid.

2. Market value of the fund as of March 31, 2018, was

- \$15.643.786.
- 3. Total fund gross returns for the quarter were -0.21%, outperforming the policy benchmark of -0.65%. Fiscal YTD total fund gross returns were 3.63%, outperforming the benchmark of 3.20%. Trailing total fund gross returns for the 1, 3, and 5 year periods were 10.96%, 5.89%, and 7.63%. Since inception (1/1/1999) total fund gross returns were 6.14%, outperforming the policy benchmark of 5.40%.

4. Kerry Richardville stated all asset classes were on target and in line with the Investment Policy Statement. No changes were

recommended at this time.

c. Christiansen & Dehner, Lee Dehner, Board Attorney.

1. Lee Dehner stated there were no new legislative updates from Tallahassee.
